

Teagasc Distance Education Green Cert Programme (for Award Holders)

We are now accepting **ONLINE** applications for the "Teagasc Distance Education Green Cert for Award Holders. See page two for details.

"Saturday Option" course commencing 18th October 2025 – see page 2 for details

This course consists of attending one Saturday a month from 8am to 6pm in Pallaskenry and online tuition.

Online content will be delivered weekly @ 7pm live with the live recording made available subsequently. This will be discussed at induction.

Aim: This course has been developed to meet the training requirements of graduates from other non-agricultural award programmes who are interested in farming.

On **successful completion** of the program, students will meet the requirements of a qualified farmer/trained farmer for the purposes of Revenue Commissioners tax exemptions and Department of Agriculture (DAFM) schemes.

Please contact your **Local Teagasc Education Officer** to check if this course is the appropriate route to meet your training requirements.

Qualifications Awarded:

- 1. Level 5 Certificate in Agriculture 5M20454
- 2. Level 6 Specific Purpose Certificate in Farming 6S20487 (Your application includes both awards)

Included in the awards above are:

• Training necessary to register as a Professional User (PU) of pesticides

Duration: The course extends over **12** months

Entry Requirements, applicants must:

- Be the holder of a Level 6 or higher major award
- Have continuous access to a commercial farm in the Republic of Ireland (home farm or approved nominated farm) to develop proficiency in farm tasks and complete farm based assignments and projects.
- Have access to all farm details including financial details on the nominated farm and are expected
 to spend time weekly on this farm and be involved in the farm operation and management.

How to Apply

Log in to https://salesianag.ie/distance-education-course and follow the "Apply Now" link.

Please have items 1 to 4 available to you for uploading during the application process:

1) Certified copy of your qualification - Applicants are required to submit a certified copy of their award parchment. Copy your qualification parchment and have the copy certified as a true copy of the original in any Teagasc office or Garda Station.

Alternatively, a full transcript of results [for each year of the course] is acceptable. The transcript must be accompanied by a covering letter from the awarding body stating the candidate's name, address, the years in which the candidate was a registered student, name of award, and the date the award was conferred.

YOUR <u>QUALIFICATION</u> MUST BE CERTIFIED IN EITHER A TEAGASC OFFICE OR GARDA STATION AS PER THE INSTRUCTIONS ABOVE.

2) Evidence/proof of your PPS (Personal Public Service Number)

(e.g. copy of public services card (front and back as your PPS number is on the back), certificate of tax credits, letter from Revenue, etc.

- 4) Copy of your driver's licence both front and back are required

For each of these awards a number of quality assurance processes and procedures must be completed by Salesian Agricultural College and Teagasc. Courses must be internally and externally verified, results approval and sign off, details exported to QQI for certification.

This process takes a minimum of eight months.

To support an application for an exemption from Communications an applicant will be required to have their qualification parchment copied and the copy verified as a true copy at a Teagasc office. Applicants will be required to submit this verified copy of their award with their application.

In the absence of a parchment, a full transcript of results for each year of the programme is acceptable, if accompanied by a covering letter from the awarding body stating the candidate's name, address, award title, award level, duration of the programme, years the candidate was a registered learner with the provider and date award conferred.

Why it's worth getting the Green Cert

am often asked by farmers whether their son or daughter should do the Green Cert course. In most cases the answer is yes because if that son or daughter is to have any involvement in the farm, there are likely to be some worthwhile benefits. Ideally, get the Green Cert well before turn-ing 35.

Young trained farmer

The definition of a young trained farmer can cause a lot of confusion. The 'trained' part is easy in that the person must have a Green Cert or equivalent.

The 'young' part is not so simple: for certain schemes associated with the CAP reform programme (EU funded) a young trained farmer is 40 or under, whereas in the case of the Stamp Duty Exemption Scheme and 100pc Stock Re-lief Scheme (government funded), it means under 35. It appears that by applying European standards, farmers stay young for longer.

Inheritance tax saving

Being a young trained farmer has no bearing on whether you pay gift or inheritance tax. However, being a trained farmer (not neces-

sarily under 35) may be of significant benefit if the transferee intends to farm the holding while also working off the farm for more than 50pc of their normal working hours: eligibili-ty for Agricultural Relief (a reduction of 90pc in the tax value) may apply in such cases if the transferee has a Green Cert or equivalent.

Where the transferee intends to work fulltime on the farm, a Green Cert or equivalent is not required, nor does the person need to be under 35 to avoid tax.

There are various schemes, incentives and

There are various schemes, incentives and benefits that favour young trained farmers and can be of significant financial benefit for young farmers starting up and taking over a farm. All these incentives are also available to young trained farmers farming in partnership

with a parent or other qualifying person.

Stamp duty exemption

Where land is gifted or purchased, a stamp duty exemption applies to farmers who are under 35 and possess a Green Cert or equivalent. The relief applies where no power of revocation exists and runs until December 31, 2025.

The land must be retained for five years and must be farmed by the transferee for at least

50pc (typically 20 hours) of his /her normal weekly working hours. There is a notable distinction between this relief and other reliefs, such as Agricultural

It appears that by applying European standards, farmers stay young for longer

Relief, in that the usage conditions can only be satisfied by the transferee and the period for which the land must be farmed is five years and not six years.

There is an lifetime ceiling on the amount of relief available on transfers and purchases which equates with €100,000 in tax value to include any relief granted under the 100pc Stock Relief Scheme and the Succession Partnership

For qualifying family transfers, the cash val-ue of the Stamp Duty exemption is deemed to be 1pc on the market value of the property being transferred.

100pc Stock Relief Scheme

A system of stock relief claimable at 100pc (with Asystem of stock refer chamador at 100pc (with no claw-back) for young qualifying farmers under 35 is available for four years from setting up. The scheme runs until December 31, 2027.

The cash equivalent amount of stock relief at the 100pc rate that a young trained farmer can receive is limited to €40,000 in a single year.

Succession farm partnership tax credits

A succession farm partnership is where an in-Asuccession lain partnersing is where ain tending transferor and an intending transfer-ee enter into a registered partnership and also sign an agreement that at least 80% of the farm will be transferred no sooner than three years' time and no later than ten years' time.

Such a partnership attracts an annual in-come tax credit of €5,000 for up to five years split annually between the partners in propor-tion to their profit-sharing ratio. In total, this can be worth up to €25,000 over the first five

Complementary income support

This CAP measure is designed to provide sup-port to young, trained farmers in the years af-ter setting up as head of the holding – solely or jointly. It provides certainty in terms of the level

jointly. It provides certainty in terms of the level of income support for up to five years. Eligible applicants who are entitled to a payment under BISS may receive a further payment per eligible hectare (max 50ha) in the region of €178/ha over the CAP period. Exact rates will fluctuate based on the level of participation. ipation.

National reserve entitlements

Young trained farmers (age limit 40) participatroung trained tarmers (age limit 40) participat-ing in BISS and setting up a farm for the first time, or who have set up such a holding during the five years preceding the first submission of a BPS application, may qualify for new en-titlements from the National Reserve, or may qualify to increase the unit value of existing en-

titlements.
Young, trained farmers participating in a partnership may also qualify

TAMS grants 20pc top-up

A top-up of 20pc can apply to young trained farmers (not over 40) resulting in a 60pc grant on approved investment costing up to a maximum investment of €90,000.
